This letter is respectfully submitted in support of Dr. Walter White's petition for classification as a qualified immigrant under the first preference employment immigration for Aliens of Extraordinary Ability pursuant to section 203(b)(1)(A) of the Immigration and Nationality Act ("the Act") 8 U.S.C. §1153(b)(1)(A). The evidence submitted here specifically demonstrates that:

1. Dr. Walter White has a level of expertise indicating that he is one of that small percentage who has risen to the very top of the field of Organic Chemistry.
2. Dr. White provides evidence that he satisfies four of ten criteria listed in 8 CFR, Section 204.5(h)(3), namely:
 - **204.5(h)(3) iii:** Published material about Dr. Walter White's research in Organic Chemistry in professional or major trade publications or other major media. (*Please refer to Section. 2.1.1*)
 - **204.5(h)(3) iv:** Participation of Dr. Walter White as a judge of the work of others in the field of Organic Chemistry. (*Please refer to Section. 2.1.2*)
 - **204.5(h)(3) v:** Evidence of Dr. White's original scientific and scholarly contributions of major significance in the field. (*Please refer to Section. 2.1.3*)
 - **204.5(h)(3) vi** Evidence of Dr. Walter White's authorship of scholarly articles in the field, in professional or major trade publications or other major media. (*Please refer to Section. 2.1.4*)

3. Dr. White Dr. Walter White's work will substantially benefit prospectively the United States (please refer to Section. 3)
4. Dr. White In the United States, Dr. Walter White plans to continue work in the area of expertise. (please refer to Exhibit 4 : signed statement from Dr. Walter White on his plans for continuing work in the U.S. and to Exhibit 14 his current job offer)
